Border Group Parish Council Minutes of a meeting of the Parish Council held on Tuesday 19th January 2016 at 7.30p.m at Lingen Village Hall.

2. Declarations of Interest and written requests for dispensations: None

No requests for dispensations

3. Open Session – brief verbal reports received from:

3.1 Ward Cllr Carole Gandy – Cllr Gandy reported that HC budget will be considered on 21.1.16 with a proposal to increase Council Tax by 3.9% to safeguard Adult Social Care – which will be ring-fenced. Central govt has allowed an increase of 2% in Council tax this financial year in recognition of cuts to budget. Funding has dropped by 80% in last 5 years and future funding will be found from Council tax and business rates rather than Central govt. although some top up funding may be available given the rural nature of Herefordshire. A decision on the Library service will be made in October 16

Cllr Gandy also reported she is now the Vice-chair of the Overview and Scrutiny Committee and is also tasked separately with reviewing Early Years (0-5) Provision. She concluded by saying she had been very impressed with Border Group's draft Neighbourhood Plan.

- 3.2 Locality Steward –Mike Brooks reported that Balfour Beatty are finalising their Annual Plan setting out work for 16/17. £800, 000 has been set aside for A, C and U roads respectively. Reeves Lane is with the Drainage team and the request for a mirror at the junction will be considered if one was there previously. If there was no mirror before then none will be provided. (It was thought that the last one had been hit by a tractor). It was pointed out that the 2 grit bins requested January 2015 had still not been installed and Mike AGREED to follow up. He also confirmed that Balfour Beatty were monitoring the culvert on the C1001 between Coxall and Brampton Bryan
- 3.3 PCSO no report this month but regular SNT (Safer Neighbourhood Team) newsletter is circulated
- 3.4 Reports from Chair/other Cllrs Chair gave a brief resume of his recent visit to Israel to gain an insight into their farming and irrigation methods and associated challenges.
 - Cllr Walker reported on a meeting he had attended on the Examination of the Core Strategy where it was confirmed that the figure of 14% increase in housing would

be reduced if local environmental factors preclude this e.g flood plains. The Core Strategy will be under review at least every 5 years which has implications for our Neighbourhood Plan should there be any changes to Core Strategy in future. It was also pointed out that affordable housing targets may not be met as such developments are less profitable and therefore not always economically viable for builders.

3.5 Local residents – concerns were raised again about the need for gritting on the C1007 between Birtley and Brampton Bryan as it is the route for the school bus. This was brought up last year but seems no progress. The Locality steward will investigate.

Brampton Bryan – problem with water drainage in village compounded by difficulty in locating the outlet to relieve the drains. There is also a loose manhole cover (BT) which passing traffic makes very noisy. Concerns were also raised about speeding by lorries from Radnor Hills site.

8. Highways

8.1 P3 (footpaths) – no work carried out this month due to very wet weather 8.2. Lengthsman Scheme – opening grips to reduce water levels in Brampton Bryan and Stoneybridge. It was reported that a resident had obtained a quote for a drain to be put in at the latter to alleviate the flood risk. It was **AGREED** that BGPC should ask Balfour Beatty if the lengthsman grant could be used to fund this. (Approx £2,500 had been set aside for drainage work from the lengthsman budget). It was **AGREED** to keep on agenda for February.

The culvert at Walford needs cleaning and work required to a tree in Lingen churchyard

- 8.3 SIDS AGREED Clerk would follow up costs and see if it was possible to purchase our own device
- 8.4 It was **AGREED** that the roads from Adforton to Letton and Lingen to Wigmore should be top priority for resurfacing
- 8.5 Litter along A4113 much of it is packaging and is blown off lorries as they pass through. It was **AGREED** to try and identify the source and contact business concerned as believed to be local.
- 8.6 It was **NOTED** that moving the sign would require a Traffic order with a wait of at least 8 years.
- **9**. **The Old Chapel, Adforton** –No progress since last meeting. It was felt the owner was not delivering on his promises but Cllr Gandy reported enforcement action unlikely before Spring as might be deemed unreasonable in current weather. **AGREED** to keep on agenda
- **10. Information Sheet -**Members noted the Information Sheet.
